
NOW THEREFORE BE IT RESOLVED by the Council of the City of Sherwood as follows:

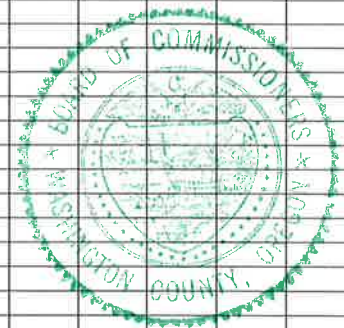
