A RESOLUTION CANVASSING RETURNS OF THE MARCH 10, 1998, ELECTION, PROCLAIMING RESULTS AND DIRECTING THE RECORDER TO ENTER ELECTION RESULTS IN THE RECORD.

WHEREAS, there has been duly and regularly certified to the City, by the Washington County Clerk, the following returns of the election held in the City of Sherwood on March 10, 1998, where at the election the question, "shall the City Charter be amended to require approval of annexations by a majority of votes in election called for that purpose?," was submitted to the electors.

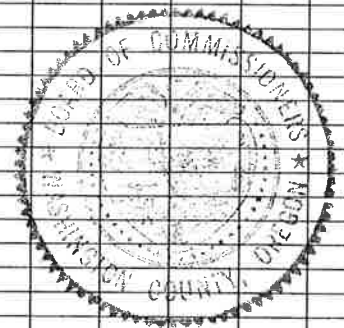
