



Resolution No. 99-824

A RESOLUTION DECLARING THE DISPOSITION OF SURPLUS MATERIALS AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City has surplus materials, supplies and property which are no longer needed for City Operations; and

WHEREAS, surplus materials, supplies and property are described in "Exhibit A."

NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

Section 1. Adoption: The City Council orders that items listed in Exhibit A become labeled as surplus and that the City dispose of the property according to applicable state statutes.

Section 2. Effective Date: The resolution will become effective upon adoption.


