



Resolution No. 2001-941

A RESOLUTION ADOPTING A SCHEDULE OF CITY WATER SERVICE CHARGES AND FEES AS ESTABLISHED BY ORDINANCE 514 ORIGINALLY ADOPTED ON MAY 5 1961 AND LAST AMENDED BY ORDINANCE 99-1071 IN FEBUARY 1999.

WHEREAS, the City has established fees for water service provided by the City originally in Ordinance No. 514 and last updated by Ordinance 99-1071; and

WHEREAS, the City has repealed Ordnance 99-1071, establishing rates and fees for water service provided by the City; and

WHEREAS, it is most appropriate that fees and charges for all services be set by the City Council, and at a level whereby reasonable costs are recovered; and

WHEREAS, the City has met the requirement for providing a public notice and public hearing prior to the adoption of this fee resolution.

NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

<u>Section 1. Adoption:</u> The City Water Schedule of Fees, attached hereto as Exhibit A, is hereby approved and adopted, and supersedes all prior water fee schedules and miscellaneous fee schedules.

Section 2. Effective Date: This Resolution shall become effective upon passage.
