**NOW THEREFORE BE IT RESOLVED AS FOLLOWS:**





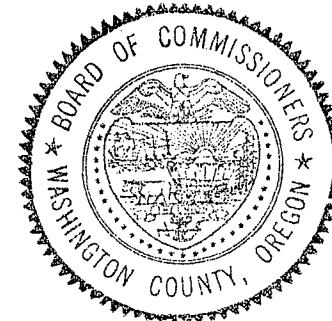
