

## Resolution No. 2002-004

## A RESOLUTION AWARDING BID FOR SHERWOOD POLICE FACILITY

WHEREAS, the February 2001 Bond Levy allocated funds for construction of a new Sherwood Police Facility; and

WHEREAS, Sherwood Police Facility includes civil, structural, architectural, mechanical, and electrical materials and services for the construction of an approximately 17,200 square foot facility; and

WHEREAS, the City of Sherwood advertised for bids for Sherwood Police Facility; and

WHEREAS, *MJD Development, Inc.* of Tigard, Oregon submitted the low bid for the project in the amount of \$2,265,446.00, which consists of all labor, materials, and equipment necessary to complete the work; and

WHEREAS, staff recommends establishing a contingency of 10% of the base bid.

## NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

Section 1. The contract is awarded to MJD Development, Inc. of Tigard, Oregon for the amount of \$2,265,446.00.

Section 2. The City Manager is hereby authorized to execute a contract with MJD Development, Inc. in an amount of \$2,265,446.00 for Sherwood Police Facility Improvements.

<u>Section 3.</u> The Council approves a construction contingency of \$226,545.00

<u>Section 4.</u> Subject to the limitations of the City's Local Contract Review Board Rules and other applicable laws, the City Manager is authorized to enter into change orders with *MJD Development, Inc.* or enter into contracts with other contractors for services related to Sherwood Police Facility, in an amount not to exceed \$2,491,991.00.
