

Resolution No. 2002-026

A RESOLUTION AWARDING BID FOR THE HWY 99W/MEINECKE ROAD INTERSECTION IMPROVEMENTS

WHEREAS, construction of the Hwy 99W/Meinecke Road Intersection Improvements has been one of the city's highest priority transportation projects since the current Transportation Plan was adopted in 1990; and

WHEREAS, the project is funded by \$6.0 million from the Oregon Department of Transportation (ODOT) with the remainder from transportation impact fees (TIF); and

WHEREAS, the City of Sherwood advertised for bids for construction of the Hwy 99W/Meinecke Road Intersection Improvements; and

WHEREAS, C&M Construction, Inc. submitted the low bid for the project in the amount of \$3,448,494.75 which consists of all labor, materials, and equipment necessary to complete the work; and

WHEREAS, staff recommends establishing a contingency of 20% of the base bid.

NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

Section 1. The contract is awarded to C&M Construction, Inc. for the amount of \$3,448,494.75.

<u>Section 2.</u> The City Manager is hereby authorized to execute a contract with C&M Construction, Inc. in an amount of \$3,448,494.75 for the Hwy 99W/Meinecke Road Intersection Improvements.

<u>Section 3.</u> The Council approves a construction contingency of \$689,698.95.

<u>Section 4.</u> Subject to the limitations of the City's Local Contract Review Board Rules and other applicable laws, the City Manager is authorized to enter into change orders with C&M Construction, Inc. or enter into contracts with other contractors for services related to the construction of the Hwy 99W/Meinecke Road Intersection Improvements in an amount not to exceed \$689,698.95.
