A RESOLUTION ADOPTING THE 2002-03 BUDGET OF THE CITY OF SHERWOOD, MAKING APPROPRIATIONS, IMPOSING AND CATEGORIZING TAXES, AND AUTHORIZING THE CITY MANAGER TO TAKE SUCH ACTION NECESSARY TO CARRY OUT THE ADOPTED BUDGET

WHEREAS, the City Budget Committee has reviewed and acted on the proposed City Budget; and

WHEREAS, the Budget Committee has approved and recommended a balanced budget to the City Council on May 13, 2002; and

WHEREAS, in accordance with State law, the City Council has held a public hearing on the budget as approved and recommended by the Budget Committee; and

WHEREAS, the City Council desires to adopt the approved budget and carry out the programs identified in the budget;

NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

Section 1: Adoption of the 2002-03 Budget

The City Council of the City of Sherwood, Oregon hereby adopts the budget for fiscal year 2002-03 in the sum of \$39,460,037, now on file at City Hall.

Section 2: Making Appropriations

Section 3: Imposing and Categorizing Taxes

The City Council of the City of Sherwood hereby imposes the taxes provided for in the adopted budget at the City's permanent rate of \$3.2975 per thousand of assessed value for operations and in the amount of \$1,058,723 for bonded debt; and that these taxes are hereby imposed for tax year 2002-03 upon the assessed value of all taxable property within the district.
