

Resolution 2003-088

A RESOLUTION SETTING FEES FOR CERTAIN TRAFFIC VIOLATIONS

WHEREAS, base fines and minimum fines for traffic violations were revised by the State of Oregon effective September 1, 2003; and

WHEREAS, the Sherwood Municipal Court's objective in imposing fines is to encourage violators to change their behavior by recognizing the circumstances surrounding the violation and the record of the defendant;

WHEREAS, the State fines effective September 1, 2003 do not vary given the circumstances surrounding the violation and the record of the defendant;

WHEREAS, the City may set fees for traffic violations which differ from the State fines; and

NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

Section 1. The fees set forth in Exhibit A are approved and adopted.

Section 2: This Resolution shall be effective upon its approval and adoption.
