

## Resolution No. 2004-021

## A RESOLUTION AWARDING THE BID FOR THE OREGON-MURDOCK ROUNDABOUT LANDSCAPE IMPROVEMENTS

WHEREAS, Washington County has, through an IGA with the City, contributed \$26,501 to help fund the roundabout landscape improvements (Res. 2003-087); and

WHEREAS, the City advertised for bids for the Oregon-Murdock Roundabout Landscape Improvements in accordance with city and state contract rules; and

WHEREAS, Crown Landscape, Inc. submitted the lowest responsive bid for the base bid plus alternates one and two in the amount of \$125,400, consisting of all labor, materials, and equipment to complete the work; and

WHEREAS, the City Engineer recommends a contingency of 10% (\$12,540).

## NOW, THEREFORE, THE CITY RESOLVES AS FOLLOWS:

Section 1: The contract is awarded to *Crown Landscape, Inc.* for \$125,400.00 and the City Manager is hereby authorized to execute a contract with *Crown Landscape, Inc.* for \$125,400.00 for the Oregon-Murdock Roundabout Landscape Improvements.

**Section 2:** The Council approves a construction contingency of \$12,540.00.

Section 3: Subject to the limitations of the city and state contract rules and other applicable laws, the City Manager is authorized to enter into change orders with *Crown Landscape*, *Inc.* for services related to the construction of the Oregon-Murdock Roundabout Landscape Improvements in an amount not to exceed \$137,940.00.

Section 4: This Resolution shall be effective upon its approval and adoption.
