

RESOLUTION 2008-031

A RESOLUTION AUTHORIZING THE CITY MANAGER TO EXECUTE A CONTRACT WITH KNIFE RIVER FOR PAVING OF SW LOWER ROY STREET AND A PORTION OF SW BRICKYARD DRIVE

WHEREAS, the project consists of asphalt removal and asphalt overlaying from Oregon Street to 22471 SW Lower Roy Street and from 14959 SW Brickyard Drive to 14861 SW Brickyard Drive; and

WHEREAS, the City of Sherwood advertised for bids for SW Lower Roy Street and SW Brickyard Drive Overlay project; and

WHEREAS, Knife Rive submitted the low bid in the amount of \$77,587.40 which consist of all labor, materials and equipment necessary to complete the work; and

WHEREAS, Staff recommends establishing a 15% contingency for this project in the amount \$11,638.11.

NOW, THEREFORE, THE CITY OF SHERWOOD RESOLVES AS FOLLOWS:

<u>Section 1</u>. The City Manager is authorized to award a contract to Knife River in the amount of \$77,587.40.

Section 2. This Resolution shall be effective upon its approval and adoption.
