

RESOLUTION 2014-075

APPROVING THE CITY RECORDER'S CANVASSING OF THE RETURNS OF THE NOVEMBER 4, 2014 WASHINGTON COUNTY ELECTION AND DIRECTING THE CITY RECORDER TO ENTER THE RESULTS INTO THE RECORD
