APPROVING THE CITY RECORDER'S CANVASSING OF THE WASHINGTON COUNTY **ELECTION RETURNS OF THE NOVEMBER 7, 2017 ELECTION AND DIRECTING THE CITY RECORDER TO ENTER THE RESULTS INTO THE RECORD**
