

RESOLUTION 2018-076

AUTHORIZING THE CITY MANAGER TO AMEND THE EXISTING SOFTWARE AGREEMENT WITH OPENGOV TO INCREASE THE AGREEMENT AMOUNT AND ADD SOFTWARE

WHEREAS, the City Manager executed a software agreement with OpenGov effective January 8, 2017 for financial transparency software with a five-year total cost of \$23,085; and

WHEREAS, the above contract was amended effective January 1, 2018 to add the OpenGov Stories application and extend the contract term through December 31, 2022, with a new total contract cost of \$63,353.72; and

WHEREAS, OpenGov now offers an additional budget module that will streamline the City's budget process; and

WHEREAS, the budget module includes a personnel management component that will provide more accurate personnel cost projections to be used in budget preparation; and

WHEREAS, personnel costs make up nearly 75% of total expenditures within the General Fund; and

WHEREAS, maintaining accuracy in the City's five-year financial projections is critical as upcoming increases in personnel-related costs such as PERS are projected to grow dramatically; and

WHEREAS, the total five-year cost of the contract with the addition of the above-described software would be \$144,522.72; and

WHEREAS, Resolution 2018-068 requires that contract amendments which result in a total contract cost which exceeds \$100,000 must be approved by Council; and

WHEREAS, a contract amendment has been developed (attached hereto as Exhibit A) which details the additional software solutions and associated fees; and

WHEREAS, it appears to Council that acquisition of the above-described software, with its integration and compatibility with the software currently in use by the City, and approval of the attached contract amendment, are in the best interest of the City.

NOW, THEREFORE, THE CITY OF SHERWOOD RESOLVES AS FOLLOWS:

Section 1. The City Manager is authorized to execute an amendment to the existing Software Agreement with OpenGov, in a form substantially similar to the Agreement Amendment attached hereto as Exhibit A, increasing the contract amount by \$81,169 from \$63,353.72

to \$144,522.72, and to take such actions as necessary to implement the amended agreement.

Section 2. This Resolution shall be effective upon its approval and adoption.
