

ORDINANCE NO. 2

AN ORDINANCE PRESCRIBING THE LICENSE FEE FOR THE SALE OF LIQUORS AND FOR REGULATING SALOONS, BARROOMS AND DRINKING SHOPS; AND PLACES WHERE INTOXICATING LIQUORS ARE SOLD WITHIN THE TOWN OF SHERWOOD.

The People of the Town of Sherwood do Ordain as Follows:

(LICENSE FEE.)

Section 1. The license fee for the sale of liquors in the Town of Sherwood, for each retail liquor dealer, shall be at the rate of \$800.00 per annum, to be paid in advance, PROVIDED that no license shall be issued for a longer period than three months.

(LICENSE REQUIRED -- PENALTY.)

Section 2. No person or persons shall, in the Town of Sherwood, directly or indirectly, in person or by another, or otherwise, open, maintain, or carry on, any saloon, barroom, drinking shop, or any place where spiritous, vinous or malt liquors are kept for sale or in any manner disposed of; or sell or barter, deliver, or in any way dispose of for or on his or their, or any other person's account, any spiritous, vinous or malt liquors, in any such barroom, drinking shop, or place, to any person or persons, or sell or barter to any person or persons, any spiritous, vinous, or malt liquors in any barroom, drinking shop or place, without obtaining a license therefor.

LICENSE REQUIRED -- Cont'd.

Any person or persons selling liquors without first having obtained a license in accordance with the terms of this ordinance, shall, upon conviction thereof before the town court, be punished by a fine not less than \$50.00 nor more than \$300.00, or by imprisonment in the town jail not exceeding 100 days, or both such fine and imprisonment, in the discretion of the court.

(APPLICATION FOR LICENSE)

Section 3. Any person or persons desiring a license for the sale of intoxicating liquors shall present in writing his or their application to the Town Recorder of the Town of Sherwood. Such application shall state where the proposed business is to be conducted, PROVIDED, That a person commencing business shall be required to file such application at least ten days before issuance of license and shall post three notices of such application in public places. If upon investigation, the council shall be satisfied that such applicant is entitled to a license under the provisions of this ordinance, and the place where it is proposed to carry on the business is a proper place therefor, they shall approve such application and file the same with the Town Recorder; and when the applicant shall thereafter present to the Town Council, the receipt of the treasurer for the amount of the license fee for the ensuing three months, or if such application is made for a period less than three months, the receipt for such period must be presented, and a license shall be issued, as applied for, and not otherwise, except that the council may, by resolution, either grant or refuse a license, and the council may revoke a license at any time, in which case there shall be refunded to the

licensee a proportionate sum of the money paid by such licensee, equal to the proportion of the unexpired period for which such license was granted.

(COUNCIL MAY ISSUE LICENSE)

Section 4. That the Council of the Town of Sherwood may issue and re-issue all lawful licenses for the keeping of saloons, drinking shops, or places where intoxicating liquors are sold at retail within the Town of Sherwood, and may issue such license or licenses for any period not exceeding three months. Every person or persons to whom a license shall be issued under this provision of this ordinance shall pay a license fee at the rate of \$800.00 per annum, payable in advance, and if such license or licenses shall be granted for a less period than three months, the payment for same shall be for such period at the rate of \$800.00 per annum.

(EMERGENCY)

Section 5. Whereas, there is an immediate necessity that this ordinance shall take effect upon its approval by the Mayor, an emergency is hereby declared and said ordinance is hereby declared to be necessary for the immediate preservation of the health, peace and safety of the people of the Town of Sherwood for the following reasons:

That the said town of Sherwood is at present without any written ordinance pertaining to the license of saloons or drinking shops and the regulations of same; that such ordinances heretofore enacted and the record of same have been destroyed.

by fire; that it is necessary to provide a manner whereby the Council may regulate such saloons or drinking shops, issue, re-issue and revoke license or licenses in the Town of Sherwood:

THEREFORE, This ordinance shall take effect and be in force immediately upon its approval by the President of the Council.
