ORDINANCE NO. 4

AN ORDINANCE FORBIDDING THE KEEPING OF DISORDERLY BARROOMS OR DRINKING SHOPS AND PROHIBITING THE SALE OF LIQUORS TO MINORS.

The People of the Town of Sherwood do Ordain as Follows: Section 1. Any keeper of a barroom or drinking shop who shall permit any breach of the peace or disturbance of public order or decorum by noisy, riotous or disorderly conduct on the premises, when it is in his power to prevent the same, or who shall sell or give any intoxicating liquors to any person already intoxicated or an habitual drunkard, or to any person under the age of legal majority, or who shall allow or permit any person in a drunken condition or any minor to remain in or about any barroom or drinking shop under his control within the corporate limits of the Town of Sherwood, shall, upon conviction thereof before the town court, be fined not less than \$25.00 nor more than \$100.00, or be imprisoned in the town jail not less than 122 days nor more than 50 days and shall forfeit the license of such barroom or drinking shop, in the discretion of the court.

(MINORS IN BARROOM -- PENALTY.)

Section 2. Any person under the age of majority who shall frequent, be, or remain in any barroom or drinking shop, or place where intoxicating liquors are sold at retail, to be drunk on the premises, within the Town of Sherwood, shall, upon conviction thereof before the town court, be fined not less than \$25.00 nor more than \$100.00, or be imprisoned in the town jail not less than 12¹/₂ days nor more than 50 days, or both such fine and imprisonment in the discretion of the court.

(EMERGENCY)

Section 3. Whereas, there is an immediate necessity that this ordinance shall take effect upon its approval by the Mayor, an emergency is hereby declared and said ordinance is hereby declared to be necessary for the immediate preservation of the health, peace and safety of the people of the Town of Sherwood for the following reasons:

That the said town of Sherwood is at present without any written ordinance pertaining to the regulation of disorderly barrooms or drinking shops and forbidding the sale of intoxicating liquors to minors, and prohibiting minors from frequenting barrooms and drinking shops; that such ordinances heretofore enacted and the record of same have been destroyed by fire; and that it is necessary to provide regulations for disorderly barrooms and drinking shops and prohibit the sale of liquors to minors;

THEREFORE, This ordinance shall take effect and be in force immediately upon its approval by the President of the Council.
