

### **URA RESOLUTION 2009-009**

### A RESOLUTION APPROVING A FAÇADE GRANT FOR BILL STAPP, OWNER OF THE BUILDING AT 22461 SW PINE STREET IN SHERWOOD

**WHEREAS**, the Urban Renewal District created the Façade Grant Program by URA Resolution 2003-001 in January 2003 and adopted amendments to the program in May 2004; and

WHEREAS, Bill Stapp, building owner, representing the building housing What Goes Around Comes Around consignment shop at 22461 SW Pine St. in Sherwood has submitted an application for a grant shown as Exhibit A of this document; and

**WHEREAS**, the Sherwood Urban Renewal Plan Advisory Committee (SURPAC) concurs with the application and has recommended approval.

NOW, THEREFORE, THE URBAN RENEWAL AGENCY DISTRICT BOARD RESOLVES AS FOLLOWS:

The Agency Administrator is authorized to grant up to 50% of the project but no more than \$30,000 in accordance to the terms and conditions to the Façade Grant Program.


