

AN ORDINANCE REGULATING PARKING WITHIN THE CITY OF SHERWOOD,
AND PRESCRIBING PENALTIES.

THE CITY OF SHERWOOD DOES ORDAIN AS FOLLOWS:

Section 1: It shall be unlawful to leave standing or parked, a vehicle of any kind or character upon any public street or way in the City of Sherwood for the principal purpose of:

- (a) Displaying such vehicle for sale
- (b) Washing, greasing or repairing such vehicle except as may be necessitated by emergency
- (c) Displaying advertising from such vehicle
- (d) Storage, or as junkage or dead storage

for more than seventy-two (72) consecutive hours.

Section 2: Whenever the owner or driver of a vehicle discovers that such vehicle is parked immediately in front of or close to a building to which the fire department has been summoned, he shall immediately remove such vehicle from the area unless otherwise directed by police or fire officers.

Section 3: No person having control or charge of a motor vehicle shall allow it to stand on any street unattended without first fully setting its parking brakes, stopping its motor, and removing the ignition key, and, when standing upon any precipitous grade, the front wheels of the vehicle shall be angled into the curb.

Section 4: No person shall stand or park a vehicle in a street other than parallel with the edge of the roadway, headed in the direction of lawful traffic movement, and with the curbside wheels of the vehicle within 18 inches of the edge of the curb, except where the street is marked or signed for angle parking.

Section 5: Where parking space markings are placed on a street, no person shall stand or park a vehicle other than at the indicated direction and within a single marked space.

Section 6: No person shall park or leave standing a vehicle of any kind or character, whether motorized or not, on the following designated portions of the following public streets, except as may be necessitated by an emergency:

- (a) AT ANY TIME:
 1. On the Southerly half of First Street between Main Street and Park Street.
 2. On the Westerly half of North Sherwood Boulevard between Third Street and Gleneagle Drive.

(b) BETWEEN THE HOURS OF 10:00 A.M. and 12:00 NOON
ON SUNDAYS:

1. On the Easterly half of Main Street between
Second and Third Streets.

(c) BETWEEN THE HOURS OF 8:00 A.M. and 4:00 P.M. ON
MONDAY THROUGH SATURDAY:

1. In excess of two (2) hours continuously in any
one location on any City street outside of a
residential district as defined by subsection (1)
of Section 483.020 O.R.S.

Section 7: No person shall park or leave standing a motor vehicle
of any kind or character, whether motorized or not, as
follows:

- (a) Within fifteen (15) feet of a fire hydrant
- (b) Within any portion of a cross-walk
- (c) Within any area marked as a loading zone other than
for the purpose of loading or unloading cargo.

Section 8: (Section 221.340 O.R.S.) Parking ordinance violation -
mode of charging defendant - notice as complaint.

(1) In all prosecutions for violation of motor vehicle
parking ordinances in the City of Sherwood, it shall be sufficient
to charge the defendant by an unsworn written notice if the same
clearly states:

- a. The date, place and nature of the charge
- b. The time and place for defendant's appearance
in court.
- c. The name of the arresting officer
- d. The license number of the vehicle.

(2) The notice provided for in subsection (1) of this section
shall either be delivered to the defendant or placed in a conspicu-
ous place upon the vehicle involved in the violation. The notice
shall serve as the complaint in the case. In all other respects the
procedure now provided by law in such cases shall be followed.

Section 9: PENALTIES:

(a) With respect to the following designated violations of
the parking provisions of this ordinance, if the cash bail herein-
after designated be paid within the times hereinafter stated, no
further appearance or penalty will be imposed and such bail shall be
applied in full as a fine for the violation:

If bail posted within 24 hours	If bail posted after 24 hours but within 72 hours	VIOLATIONS
1.00	2.00	Within 15 feet of fire hydrant
1.00	2.00	Over 18 inches from curb
1.00	2.00	Blocking cross-walk
1.00	2.00	Over 2 hrs. on any street in posted areas between 8:00 a.m. and 4:00 p.m. Monday thru Saturday
1.00	2.00	Double parking
1.00	2.00	Parking in prohibited area
1.00	2.00	Wrong side parking

(b) Any violation of the provisions of this ordinance for which bail is not posted in the amounts and within the time prescribed in subsection (a) hereof, shall upon conviction be punishable by a fine of not more than \$50. for each violation.

Section 10: This ordinance shall be effective on the 31st day after its passage by the Council and approval by the Mayor.
