

ORDINANCE NO. 595

AN ORDINANCE AMENDING ORDINANCE NO. 546 AS ENACTED BY THE CITY COUNCIL ON JANUARY 11, 1967, AND AMENDED BY ORDINANCE NO. 585 ENACTED DECEMBER 18, 1968, WITH RESPECT TO SECTION 3 THEREOF: PRESCRIBING PLAN CHECK FEES TO BE COLLECTED FOR PROCESSING BUILDING PERMIT APPLICATIONS AND PRESCRIBING EFFECTIVE DATE

---

THE CITY OF SHERWOOD DOES ORDAIN AS FOLLOWS:

Section 1: That Section 3 of Ordinance No. 546, as enacted by the City Council and approved by the Mayor on January 11, 1967, and as amended by Ordinance No. 585, as enacted by the City Council and approved by the Mayor on December 18, 1968, be, and the same is hereby, amended by adding to Section 3 of Ordinance No. 546 subparagraph (e) to read as follows:

"(e) All persons or organizations undertaking to erect, remodel, alter, or modify any structure for which a building permit shall be required under the provisions of this code, except public schools, shall be required to pay a plan check fee to the City of Sherwood upon application for a building permit, said plan check fee being in addition to a building permit fee, and being not refundable. The plan check fees shall be paid on the basis of the value of the work to be undertaken in accordance with the following schedule:

"(i) Residential construction:

\$1,000.01 to \$5,000.00	-	\$10.00
\$5,000.01 to \$10,000.00	-	\$15.00
\$10,000.01 to \$15,000.00	-	\$17.50
\$15,000.01 to \$20,000.00	-	\$20.00
For each additional \$5,000.00 or any part thereof over \$20,000 an additional charge of	-	2.50

"(ii) Commercial and industrial construction:

\$1.00 to \$20,000.00	-	\$10.00
For each additional \$1,000 or any part thereof over \$20,000 an ad- ditional charge of	-	1.00

"(iii) Non-profit churches, hospitals,  
private schools, etc.:

\$1.00 to \$50,000.00	-	\$50.00
\$50,000 to \$100,000	-	\$75.00
All construction above \$100,000	-	\$100.00 "

Section 2: This ordinance shall be effective on and after the 31st day after final passage by the City Council and approval by the Mayor.

PASSED: By the Council, by unanimous vote of all Council members present, after being read by caption three times, and in body once, this 10 day of December, 1969.
