ORDINANCE NO. 614

AN ORDINANCE AMENDING ORDINANCE NO. 599 "MOTOR VEHICLE CODE OF THE CITY OF SHERWOOD" - BY ADDING THERETO NEW SECTIONS AND AMENDING PRE-EXISTING SECTIONS TO BRING THE SAME INTO CONFORMITY WITH PERTINENT PROVISIONS OF THE OREGON LAWS OF 1971 AS ENACTED BY THE 1971 LEGISLATIVE SESSION, AND DECLARING AN EMERGENCY

THE CITY OF SHERWOOD DOES ORDAIN AS FOLLOWS:

Section 1: That by virtue of authority contained in §221.330, Oregon Revised Statutes, all those certain sections of Chapters 483, 484, and 485, ORS, hereinafter in this ordinance listed by section number and sub-section number with suffix (S) and titles, and being section numbers identical to those of applicable sections of Oregon Revised Statutes as amended, supplemented or originally enacted by the Oregon Legislative Session of 1971, be, and each and all thereof are hereby adopted by this reference section by section, paragraph by paragraph, word by word in the entirety in all respects to the same legal force and effect as if set forth herein in full.

Section 2: Each section or sub-section of Oregon Revised Statutes hereinafter numbered and titled, when cited by section number as identified in this ordinance, together with suffix (S), shall be referenced as a section or sub-section of the "Motor Vehicle Code of the City of Sherwood", and may be cited as such.

Section 3: Chapter IV (Chapter 483, ORS) - Motor Vehicle Traffic and Equipment - of Ordinance 599 - "Motor Vehicle Code of the City of Sherwood" be, and the same is hereby amended as follows:

Section 483.020 (S) is hereby amended to conform to ORS 483.020 as amended by Chapter 393, O.L. of 1971.

Section 4: Chapter V (Chapter 484, ORS) - Traffic Offense Procedures of Ordinance 599 "Motor Vehicle Code of the City of Sherwood be, and the same is hereby amended as follows:

Section 485.010 (S) is hereby amended to conform to ORS 485.010 as amended by Section 5, Chapter 607 O.L. of 1971.

Section 485.020 (S) is hereby amended to conform to ORS 485.020 as amended by Section 6, Chapter 607, O.L. of 1971.

Section 485.030 (S) is hereby amended to conform to ORS 485.030 as amended by Section 7, Chapter 607, O.L. of 1971.

Section 6: Chapter IV (Chapter 483, ORS)- Motor Vehicle Traffic and Equipment - of Ordinance #599 "Motor Vehicle Code of the City of Sherwood" be, and the same is hereby, amended to add the following new section which by Section 2, Chapter 340, Oregon Laws of 1971, was added to and made a part of ORS 483.114 to 483.118:

Section _____ (1) The driver of any vehicle shall exercise reasonable control of the vehicle which he is driving as may be necessary to avoid colliding with any object. A collision is not necessary ^{for} violation of this section.

(2) Subsection (1) of this section does not change the rules of pleading and evidence relating to negligence and contributory negligence.

This section shall be designated in the Sherwood Motor Vehicle Code by the Oregon Revised Statutes Section number that has been or will be assigned to Section 3, Chapter 340, Oregon Laws of 1971, by the codification authority followed by the suffix "(S)".

Section 7: Inasmuch as it is necessary for the peace, health and safety of the people of the City of Sherwood that the provisions of the Motor Vehicle Code of the City of Sherwood conform to the provisions of Oregon Laws of 1971, immediately, an emergency is hereby declared to exist and this ordinance shall become effective upon its passage by the Council and approval by the Mayor.
