WHEREAS, the Urban Renewal Agency Budget Committee has reviewed and acted on the proposed Urban Renewal Agency budget; and

WHEREAS, the Budget Committee has approved and recommended a balanced budget to the Urban Renewal Agency Board of Directors on April 19, 2007; and

WHEREAS, in accordance with State law, the Urban Renewal Agency Board of Directors has held a public hearing on May 15, 2007 on the budget as approved and recommended by the Budget Committee; and

WHEREAS, the Urban Renewal Agency Board of Directors desires to adopt the approved budget and carry out the programs identified in the budget;

NOW THEREFORE THE URBAN RENEWAL AGENCY RESOLVES AS FOLLOWS:

<u>Section 1: Adoption of the 2007-08 Budget.</u> The Urban Renewal Agency Board of Directors of the City of Sherwood, Oregon hereby adopts the budget for the City of Sherwood Urban Renewal Agency for fiscal year 2007-08 in the sum of \$2,503,537, now on file at City Hall.

<u>Section 2: Making Appropriations.</u> The amounts for the fiscal year beginning July 1, 2007 and for the purposes shown below are hereby appropriated as follows:

Reimbursements	279,772
Contingency	305,547

Notes: Reimbursements are to the City of Sherwood for expenditures incurred on behalf of the URA.

WHEREAS, supplemental budgets are required:

- when a government receives revenue it did not plan for in its budget and wishes to spend the extra revenue
- occurrences or conditions which were not known at the time the budget was prepared require changes in financial planning

WHEREAS, the following events have occurred:

- the Urban Renewal District is responsible for a portion of the construction costs of the Civic Building that were financed in cash, not debt.
- Sufficient cash has accumulated, due to additional tax revenue collected, to meet a portion of the obligation;

NOW, THEREFORE, THE URBAN RENEWAL AGENCY BOARD OF DIRECTORS RESOLVES AS FOLLOWS:

SUBJECT: URA Resolution 2007-008 Bridges Financial & Realty Group Façade Grant Request

Issue: Should the Sherwood Urban Renewal District Board approve a Façade Grant for Shane and Jennifer Bridges of Bridges Financial and Realty Group?

Background: On May 2, 2007 an application was submitted by the owner of property at 15922 SW 2nd Street in Old Town for a Façade Grant. The total estimated project cost was over \$64,000. The applicant requested consideration for a \$15,000 grant. At the May 16, 2007 SURPAC meeting a full membership of 7 reviewed the application and deliberated on the request. SURPAC concluded that only the brick and rock work were eligible for grant funding. Most of the work had already been done on the commercial building or did not meet the established grant criteria. SURPAC members voted unanimously (7-0) to recommend to the District Board approval of \$4168.50 for brick and rock work. This represents 50% of the total project cost of \$8337.00. The applicant will be required to provide samples to the planning department to ensure compliance with the Old Town Design standards.

The Façade Grant program allows any property owner who uses their building in Old Town for retail or commercial endeavors, a source of matching funds, fifty percent (50%) of the overall project cost from the district.

Financial Analysis: This program is funded from the Districts General Fund and approximately \$40,000 remains in the plan. The program still remains a matching funds program. The applicant must submit a bill for work completed before any re-imbursement will be authorized.

Recommendation: MOTION TO APPROVE THE URA Resolution 2007-008, a resolution authorizing the District Board to award a Façade Grant of \$4168.50 to Shane and Jennifer Bridges, Bridges Financial & Realty Group for the exterior improvements to their commercial building at 15922 SW 2nd Street, Sherwood Oregon 97140

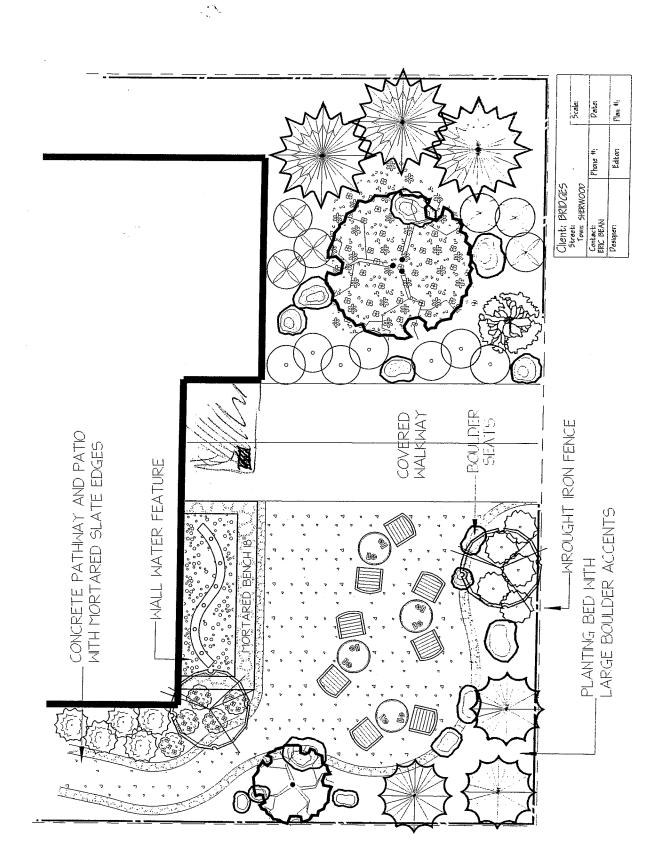

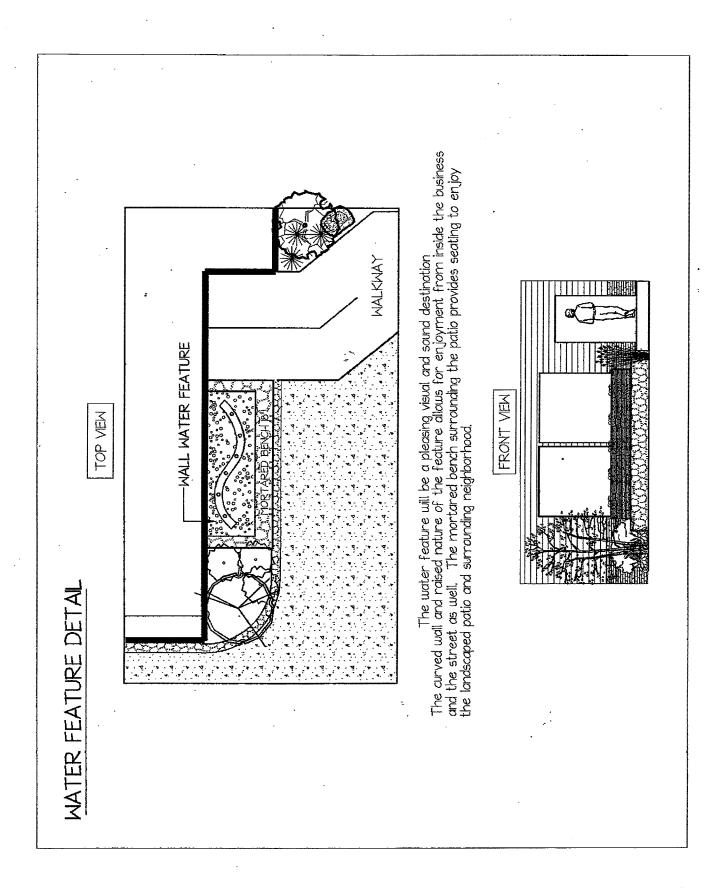

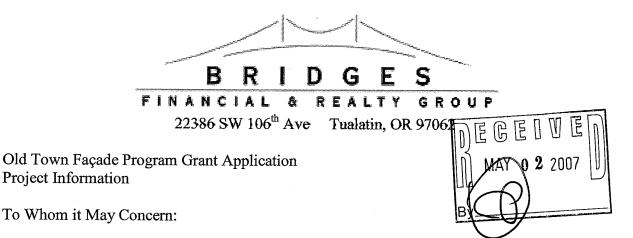

C. URA Resolution 2007-008 Approval of Façade Grant for Bridges Financial

Mr. Heironimus asked if this was the lime green house on Second street UR District Manager Jim Patterson replied, he did not believe it was lime green, but the house has a brick façade and stated it's the building behind Nottingham's that has been approved for the Morgan & Realty Company.

Ms. Henderson asked how long has Bridges Financial been doing business in town. Mr. Patterson replied they are moving their business from Tualatin into this new facility and they will be employing between 10-12 people.

Ms. Henderson asked where will the employees park. Mr. Henderson then stated, never mind, this is another issue. Mr. Patterson replied, this was a great question.

Ms. Henderson asked if anyone else has applied for a Façade Grant that is currently in Sherwood or that has been here for a while. And stated she thought the Façade Grant had been exhausted. Mr. Patterson replied, he bring the grant requests forward as he receives them and there is about \$40,000 remaining from the original \$150,000.

Mr. Patterson informed Council, SURPAC would be recommending to the District Board whether or not the Façade Grant should be recharged.

Mr. Patterson stated the original request on this Façade Grant was for well above \$15,000 and as it went through the process, SURPAC determined this part was eligible and met the criteria (see record for Façade Application).

Chair Mays asked for other questions, with none heard, he asked for a motion.

MOTION: FROM MR. WEISLOGEL, SECONDED BY MR. KING TO APPROVE URA RESOLUTION 2007-008. UNANIMOUSLY APPROVED BY ALL MEMBERS PRESENT
