ORDINANCE NO. 86-852

AN ORDINANCE AMENDING ORDINANCE NO. 561 REGULATING PARKING WITHIN THE CITY OF SHERWOOD AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, limited street widths affect the accessibility of emergency vehicles to certain areas within the City and;

WHEREAS, limiting the parking to one side of the street in these areas would greatly reduce the accessibility problems encountered by emergency vehicles;

NOW, THEREFORE, THE CITY OF SHERWOOD DOES ORDAIN AS FOLLOWS:

- Section 1. No parking shall be allowed on the northeasterly side of N.W. Park St. from Railroad St. to N.W. 2nd St.
- Section 2. No parking shall be allowed on the northeasterly side of N.W. Main St. from Railroad St. to N.W. 3rd St.
- Section 3. No parking shall be allowed on the northeasterly side of N. Pine St. from Railroad St. to N.E. Oregon St. and from the alleyway between N.E. 2nd St. and N.E. 3rd St. to N.E. 3rd St.
- Section 4. No parking shall be allowed on the northeasterly side of N.E. Oak St. from N.E. Oregon St. to the end of the curb approximately 150' north of N.E. 2nd St.
- Section 5. No parking shall be allowed on the northwesterly side of N.E. Ash St. from N.E. Oregon St. to the end of the curb at approximately 150' northerly of N.E. 1st. St.
- Section 6. No parking shall be allowed on N.E. Oregon St. from North Pine St. to the Railroad crossing.
- Section 7. No parking shall be allowed on the northwesterly side of N.W. 1st St. from N.W. Park St. to N.W. Main St. and on the northwesterly side of N.E. 1st. St. from North Pine St. to approximately 100' easterly of N.E. Ash St.

- Section 8. No parking shall be allowed on the southeasterly side of N.W. 2nd St. from N.W. Park St. to North Pine St.
- Section 9. No parking shall be allowed on the southeasterly side of N.E. 2nd St. from North Pine St. to N.E. Oak St. and on the northwesterly side of N.E. 2nd St. from N.E. Oak St. to the end of the curb at approximately 150' easterly of N.E. Oak St.
- Section 10. No parking shall be allowed on the northwesterly side of N.W. 3rd St. from N.W. Main St. to North Pine St.
- Section 11. No parking shall be allowed on the southeasterly side of N.E. 3rd St. from North Pine St. to 50' easterly of Pine St. and on the northwesterly side of N.E. 3rd St.
- Section 12. The City Manager is directed to cause standard traffic signs to be installed or removed as necessary to carry out the foregoing provisions.
- Section 13. This ordinance shall be effective thirty (30) days after passage and approval.

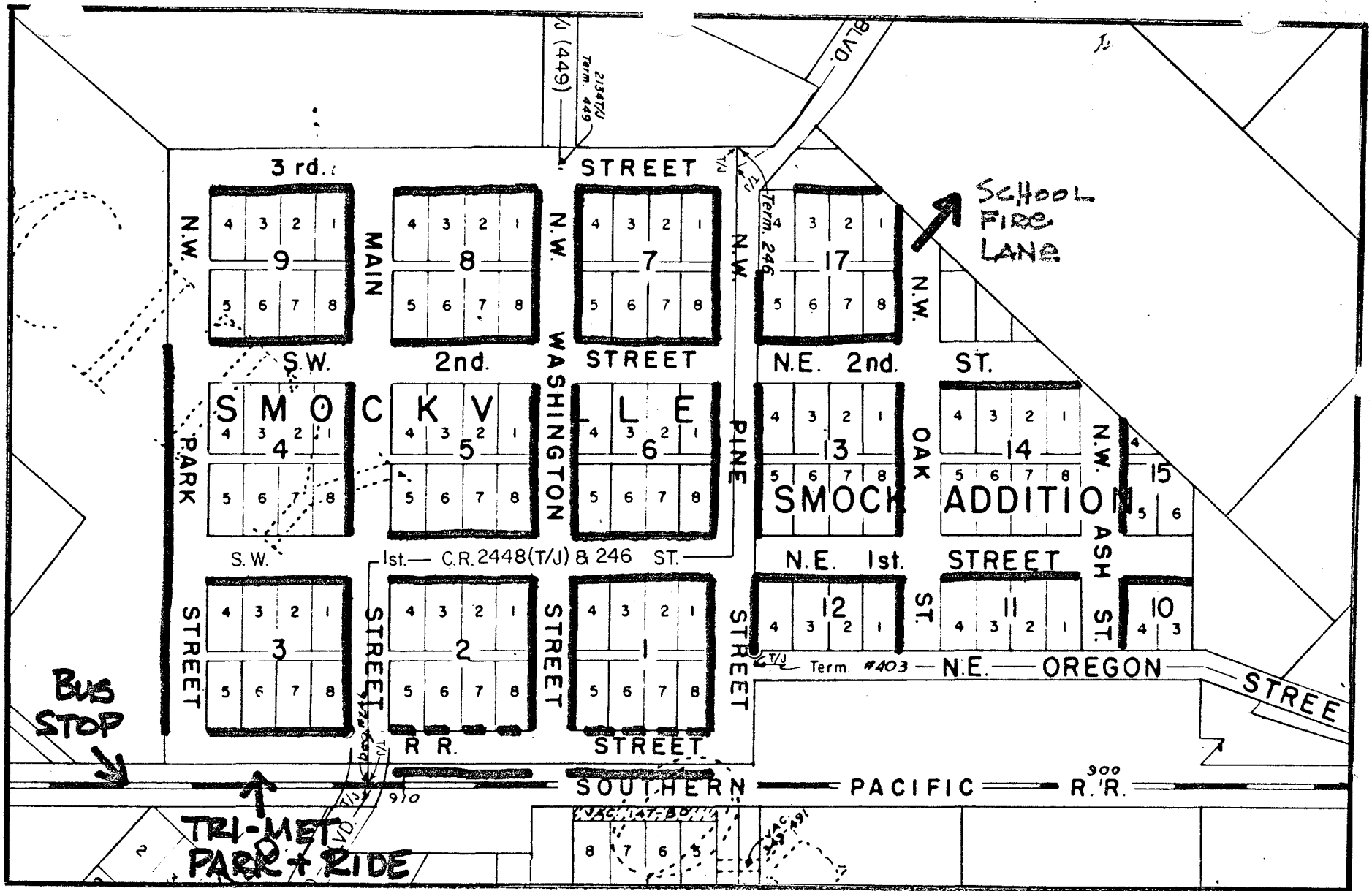
