ORDINANCE NO. 87-858

AN ORDINANCE ESTABLISHING ADDITIONAL PROVISIONS REGULATING VEHICLES AND TRAFFIC ON PRIVATE PROPERTY, STREETS, AND PARKS, REPEALING OBSOLETE SECTIONS, AND RENUMBERING SECTIONS ACCORDINGLY, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, Chapter IX of the City Ordinances regulating vehicles and traffic enumerate additional and miscellaneous provisions for the safety of persons and vehicles; and

WHEREAS, over the past year the Council has heard from numerous citizens regarding unsafe, but previously unregulated, practices on City streets and property; and

NOW THEREFORE, THE CITY OF SHERWOOD ORDAINS AS FOLLOWS:

<u>Section 1: Code Amended</u>. Chapter 5.IX of the General Ordinances of the City of Sherwood, regulating vehicles and traffic, is hereby amended to include three new sections, to read:

Section 15. <u>Crossing Private Property</u>. No operator of a vehicle shall proceed from one street to an intersecting street by crossing private property. This provision shall not apply to the operator of a vehicle who stops on the property for the purpose of procuring goods or services.

Section 16. <u>Driving in Parks</u>. No person in a park shall drive any vehicle on any area except on park roads or parking areas, or such other areas as may on occasion be specifically designated as temporary parking areas by the City Manager.

Section 17. <u>Sleds, Skis, Toboggans, and Skateboards on</u> <u>Streets</u>. No person shall use the streets for travelling on skis, tobaggans, sleds, skate boards, roller skates, or similar devices, except where authorized.

<u>Section</u> <u>2</u>: <u>Sections Repealed</u>. Sections 15 and 16 of Chapter 5.IX are hereby repealed, as they are replaced by new Section 17.

<u>Section 3:</u> <u>Sections Renumbered</u>. Existing Sections 17 through 26 of Chapter 5.IX are hereby renumbered Sections 18 through 27.
