ORDINANCE NO. 88-888

AN ORDINANCE AMENDING SOLID WASTE COLLECTION RATES IN THE CITY TO REFLECT RECENT CHANGES IN LANDFILL DISPOSAL RATES CHARGED BY THE METROPOLITAN SERVICE DISTRICT, AND ESTABLISHING AN EFFECTIVE DATE

Whereas, Pride Disposal, the City's franchised solid waste collection agent, has petitioned the City for an increase to local rates to reflect increases to regional landfill disposal rates that were effective November 1, 1988, and

Whereas, Ordinance No. 87-864 modified the City's Solid Waste Management Ordinance No. 816 to allow for "pass-through" increases to local rates in recognition of regional rate changes, and

Whereas, the Council heard a presentation from Pride Disposal on October 26, 1988 and conducted a public hearing on the local rate increase at that time, and also received information from the Metropolitan Service District regarding regional rate changes.

NOW, THEREFORE, THE CITY OF SHERWOOD ORDAINS AS FOLLOWS:

Section 1. Pass-Through: That the rate increase requested by Pride Disposal, and attached hereto as Exhibt "A", is deemed to be a "pass-through" increase as per Ordinance No. 87-864, and is an accurate reflection of the local impact of regional landfill disposal fee increases.

Section 2. Approval: That the new rate schedule attached as Exhibit "A" is hereby APPROVED and ADOPTED.

Section 3. Effective Date: To provide for safe and sanitary solid waste management in the City and thereby preserve the health, safety and welfare of the residents thereof, an emergency is declared to exist and the terms and provisions of this Ordinance shall be retroactively effective to November 1, 1988.
