ORDINANCE NO. 91-932

AN ORDINANCE ESTABLISHING FEES AND CHARGES FOR MISCELLANEOUS CITY SERVICES, SUCH AS POLICE REPORTS, PARKING REGULATIONS, RECORDS, UTILITY AND OTHER SERVICES, AND ACTIVITIES, ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, the City performs and offers certain miscellaneous services, the cost of which are most reasonably borne by the recipient, as opposed to paying for said services from general City funds; and

WHEREAS, in April, 1987, staff prepared and the City Council reviewed, a list of such miscellaneous services for which the City did not assess direct charges, or for which fees have been set administratively; and

WHEREAS, the cost of miscellaneous services and the cost of doing business in general has risen appreciably since 1987; and

WHEREAS, it is most appropriate that fees and charges for miscellaneous services be set by the Council, and at a level whereby reasonable costs are recovered.

NOW, THEREFORE, THE CITY ORDAINS AS FOLLOWS:

Section 1. Rates Established. The following services shall be charged out at the level of fees indicated:
