ORDINANCE NO. 2000-1088

AN ORDINANCE AMENDING ORDINANCE NO. 89-899 SOLID WASTE COLLECTION RATES WITH RESPECT TO COMMERCIAL CONTAINERS AND WITH RESPECT TO DROP BOXES BY AMENDING THE RATE TABLE OF SAID ORDINANCE (TABLE 8.20.80 IN CITY CODE SECTION 8.20.080) AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, solid waste collection is regulated in the City by a franchise granted to Pride Disposal, Inc., and the terms and conditions of said franchise are set by Ordinance 89-899 as subsequently amended; and

WHEREAS, there has been a request for an amendment to the adopted rates for certain categories of solid waste collection service, and the Council has received the recommendation of the City Manager on request as required by Code Section 8.20.080 E.2, and the Council has, after proper notice, conducted a public hearing on the proposed rate adjustment as required by Code Section 8.20.80 E.3, and finds that the rates should be amended as set forth hereinafter in this ordinance.

NOW, THEREFORE, THE CITY OF SHERWOOD DOES ORDAIN AS FOLLOWS:

Section 1. The rates set forth for the categories of service specified on Exhibit A to this Ordinance are hereby adopted, and the rate table of Ordinance 89-899 (City Code Section 8.20.080, Table 8.20.080) is hereby amended to conform to those rates specific on said Exhibit A.

Section 2. Effective Date. This ordinance shall become effective the 30th day after its enactment by the City Council and approval by the Mayor.
