

**City of Sherwood, Oregon  
Ordinance 2006-003**

**AN ORDINANCE AMENDING SECTION 15.04.140 OF THE SHERWOOD MUNICIPAL CODE ADOPTING THE 2005 OREGON ELECTRICAL SPECIALTY CODE; DECLARING AN EMERGENCY.**

**WHEREAS**, the State of Oregon has (pursuant to OAR 918-305-0100) adopted an updated version of the Oregon Electrical Specialty Code based on NFPA 70-2005, National Electrical Code (NEC), 2005 Edition as published by the National Fire Protection Association;

**WHEREAS**, the City of Sherwood has assumed the administration and enforcement of a building inspection program and therefore must, under the terms of ORS 455.148, enforce updated specialty codes the 2005 Oregon Electrical Specialty Code as adopted by the State of Oregon for plan review, permits and inspections.

**NOW, THEREFORE, THE CITY OF SHERWOOD ORDAINS AS FOLLOWS:**

Section 1. Section 15.04.140 is hereby amended to read as follows:

**15.04.140 Electrical Code.**


The City of Sherwood shall use the 2005 Oregon Electrical Specialty Code for administration, plan review and inspection as the same has been adopted and described in OAR 918-305-0100(1). Any provision in this Chapter inconsistent with the terms of that 2005 Code is hereby to be deemed ineffective and without force.

Section 2. The Oregon Electrical Specialty Code is available at the Building Department at Sherwood City Hall 22560 SW Pine Street.

Section 3. Effective Date: It is necessary that the Code provision adopted by this ordinance be immediately effective so there is no question the City is complying with the State's mandate to enforce the most current building code which in turn will promote the peace, health safety and welfare of the citizens of Sherwood; now therefore this ordinance is and shall be effective from and after its passage by the Council.
