CITY OF SHERWOOD ORDINANCE 2006-011

AN ORDINANCE APPROVING VACATION OF A PORTION OF HANDLEY STREET AND ACCEPTING A PUBLIC UTILITY EASEMENT OVER THE VACATED AREA.

WHEREAS, the City Engineer has determined that the public right-of-way including tracts of land totaling 12,630 square feet, more or less, adjacent to Handley Street near SW Pacific Highway (99W) Sherwood, Oregon, SW ¼ of Section 30, Township 2 South, Range 1 West, Willamette Meridian, Washington County, Oregon as shown on Exhibit B is not required for public access and is a portion of the abandoned access to the Vineyards, and as such is no longer an asset to the City's street system; and

WHEREAS, the Sherwood City Council may initiate right-of way vacation on its own motion, as stipulated in ORS 271.130, with notice to abutting property owners and sixty-eight percent of the property owners within the notification area consented to the petition which means a majority of the property owners affected by the vacation have not objected in writing to the petition; and

WHEREAS, a public hearing was held at 7:00 pm, May 2, 2006 in the Community Room in the City Hall, Sherwood, Oregon after the City gave notice of the hearing by posting as required by law, including the posting of the notices in certain places and within the portion of the public right-of-way area to be vacated with the notices remaining posted for the period required by law, all in accordance with ORS 271.110 et seq.

WHEREAS, A notice was also published in the local newspaper on April 27, 2006 consistent with the requirements of ORS 271.110 (1); and

WHEREAS; the Sherwood City Council received a staff report with findings, at the public hearing on the proposed street vacation on May 2, 2006, and found the vacation of right-of-way to be in the public interest, via Resolution 2006-025.

NOW, THERFORE, THE CITY OF SHERWOOD ORDAINS AS FOLLOWS:

<u>Section 1. Council Review & Public Hearings.</u> The proposal by the City Engineer to vacate the public's interest in a portion of Handley Street was subject to full and proper review, and a public hearing was held before the Council on May 2, 2006. The City Recorder has certified that the affected property is free of all City liens and no taxes are owed on the affected property as required by ORS 271.130(3).

<u>Section 2.</u> Findings. After full and due consideration of the application, the City staff report, the record, findings, and the evidence presented at the public hearing, the Council finds that the subject portion of Handley Street should be vacated, and title to

the area will attach to the adjacent property owners of tax lots 1600 and 101 of Section 30, Township 2 South, Range 1 East W.M. Legal description of the affected portions of the vacated right-of-way is attached as Exhibit B. Further, a permanent public easement over the vacated portion of Handley Street as shown in Exhibit C is hereby established.

<u>Section 3. Approval.</u> The proposal for street vacation is hereby approved for that area stipulated in the document labeled "Exhibit B" and attached to this ordinance. Further, a permanent public easement over the vacated portion of Handley Street as shown in Exhibit C is hereby established.

<u>Section 4.</u> City Engineer Authorized. The City Engineer is thereby authorized and directed to take such action as may be necessary to document this street vacation, including recording of a certified copy of the Ordinance, and filing of a certified copy of this ordinance with the county assessor and county surveyor, in accordance with Washington County ordinances and regulations.

<u>Section 5.</u> Effective Date. This Ordinance shall become effective 30 days from its adoption.


