



## ORDINANCE 2008-010

### AN ORDINANCE TO CONFIRM THE NAME OF SW BAKER ROAD AS THE OFFICIAL NAME

**WHEREAS;** this section of road has been variously called Baker Road, Murdock Road, Brown Road, and Wilsonville Road; and

**WHEREAS;** the City has an interest in seeing the road name confusion clarified; and

**WHEREAS;** this section of road is in City jurisdiction and has never been formally named; and

**WHEREAS;** clear and consistent naming of this section of road is needed to avoid confusion in emergency response, mail service, delivery, and other incidental issues; and

**WHEREAS;** an action to rename a street in the City may be initiated by the City Council as set forth in Sherwood Municipal Code 16.108.010.2C and 3.A.1; and

**WHEREAS;** a public hearing was held on 7:00 pm, June 17, 2008 before the City Council. The City gave notice of the hearing by posting as required by law, including the posting of the notices in certain places and within the portion of the public right-of-way area to be renamed. The notices were posted and remained posted for the period required by law, all in accordance with the Sherwood Municipal Code. Notices were also published in the local newspaper on May 22, 2008 consistent with the requirements of the Sherwood Municipal Code.

### **NOW, THEREFORE, THE CITY OF SHERWOOD ORDAINS AS FOLLOWS:**

SECTION 1. Council Review & Public Hearings. The proposal to confirm the name of Baker Road as the official road name, as shown in Exhibit A, was subject to full and proper review, and a public hearing was held before the Council on June 17, 2008.

SECTION 2. Findings. After full and due consideration of the application, the City staff report, the record, findings, and evidence presented at the public hearing, the Council finds that the segment of road from the intersection of Sunset Boulevard and


Murdock Road south to the City limits is appropriately named Baker Road.

SECTION 3. Approval. The proposal to officially name the road segment between the intersection of Sunset Boulevard and Murdock Road south to the City limits as Baker Road is hereby approved.

SECTION 4. City Engineer Authorized. The City Engineer is authorized and directed to take such action as may be necessary to document this road naming, including recordation of a certified copy of the Ordinance, and filing of a certified copy of this ordinance with the county assessor and county surveyor, in accordance with Washington County ordinances and procedures.

SECTION 5. Effective Date. This Ordinance shall become effective 30 days from its adoption.




