City Council met pursuant to adjournment, the Mayor presiding. On roll call councilmen Young, Snyder, and Laurenz were found to be

This being the time set for hearing objections and remonstrances to the apportionment of the costs and expenses of laying down and constructing sanitary sewers and laterals inside and outside of "The South Side Sanitary Sewer District," in said City, and also a septic tank for an outlet, which sewer district was established by Ordinance No. 61 of said City, passed and approved on April 3, 1925, and no objections having been made or filed to said apportionment, and it appearing that the time for filing objections has expired, the affidavit of Douglas Herritt, publisher and orinter of the Sherwood Valley News, a weekly newspaper published in the City of Sherwood, showing that notice of said apportion and had been said apportion and had been said apportion. said apportionment had been published in said newspaper in the issue dated April 10, 1925, and also in the issue thereof dated April 17, 1925, being two consecutive issues of said newspaper, said notice being given by the Recorder of said City under date of April 6, 1925, was presented and read.

Also the affidavit of Benj. H. Tooze, Recorder of said City of Sherwood, was also presented and read, showing that, on April 925, he had caused three printed copies of said apportionment notice to be posted in public places in said City and in said South Side Sewer District, said places of posting being also conspicuous places, a copy of said printed notices, so posted, being attached to said affidavit, the said places of posting being also particularly set out and de-

scribed in said affidavit.

And it appearing that no objections were made or filed against said apportionment, Ordinance No. 62, entitled "An Ordinance declaring and assessing upon each lot, tract, or parcel of land situated within The South Side Sanitary Sewer District, in the City of Sherwood, Oregon, as created and established by Ordinance No. 61 of said City, entitled 'An Ordinance establishing a Sanitary Sewer District in the City of Sherwood, Oregon, prescribing the time and manner of constructing and laying down a sanitary sewer and laterals inside and outside of such district, for constructing a septic tank for an outlet, and providing that the costs and expenses of such improvement shall be apportioned to and assessed upon the property benefitted thereby, and declaring an emergency, ' passed by the City Council and approved by the Mayor of said City on April 3, 1925, its just share of the estimated costs and expenses of the construction and laying down of said sanitary sewer and laterals inside and outside of such district, and for the construction of said septic tank for an outlet, and directing that the assessed cost and expense be entered in the Docket of City Liens of said City as provided by the Chatter thereof, and declaring an emergency, " was introduced, and a motion was made and seconded that the ordinance be read a first time by sections, and in full. The motion was duly seconded and was adopted by unanimous vote. The ordinance was then read a first time by sections, and in full.

A motion was then made that the rules be suspended and the ordinance be read a second time by title only. The roll was called upon the motion and the vote Stood: Aye: Young, Snyder, Laurenz - 3. No: None. So the motion was declared adopted, and the ordinance was there-

upon read a second time by title only.

A motion was thereupon made and seconded that the ordinance be read a third time, by sections, and in full, and placed upon its final passage. The motion was seconded, and was adopted by unanimous vote,
