MEETING NOTES

- 1. Adjustments to Agenda-
 - No adjustments.

2. Approval of Minutes

• Bernie motioned to approve the October '05 meeting minutes, Shelly seconded, all in favor. Motion passed.

3. Council Update

• Dave Grant updated the Commission on the possibility of a name change for Sunset Park. There was representation from the Snyder family at the City Council meeting requesting the alleged verbal agreement that the park would be re-named Snyder Park.

4. Commission Priorities and Strategies

- The Commission acknowledged the need to focus their efforts in order to accomplish objectives and goals.
- Dave Grant is working on the Old School House strategy. There are three stages of goals for the building:
 - i. Cosmetic: Paint, fix boards, stair handrail, broken windows
 - ii. Fire Escape: Minimum fire escape accommodations (ramp out the back).
 - iii. Removal of the center partition wall.
- Dave believes that with minor modifications the occupancy load could be 50 people. Dave believes with the second and third goal of building renovation, that the occupancy rate would greatly increase.
- Dave is estimating that the price estimate for each stage is \$10,000 cosmetic, \$5,000 to \$10,000 fire escape ramp, and bathrooms \$10,000.
 - There are some urban renewal funds available.
- The Commission would like to view the building as three different rentable spaces.
 - Dave Grant is going to sit down with Ross and the building inspectors to find out what it will take to get started on the process. The ideas from the Commission included:
 - Recitals, lessons, Masters classes, church use, small lectures, movies, clubs monthly, karaoke, theatre performance, dance lessons, choir, small art shows, wedding receptions, refuge, blood drives, and summer camp.
 - 2. The Commission believed that there is still a need for a community center built for the community and by the community.
 - 3. Email Dave Grant with any questions or additions.

5. SWOT Meeting Preparation and Overview- Robyn

- Strengths- Good momentum, great events, diverse group, community support, and built successful partnerships.
- Weaknesses- Group of volunteers, and it is hard to manage fundraising and programming.
- Opportunities-Old school house, grants, and volunteers.
- Threats- Missed opportunities because the Commission is stretched too thin.
