MEETING NOTES

- 1. Adjustments to Agenda
 - No adjustments were made to the agenda.

2. Approval of Minutes

• Doug Pederson motioned to approve the October 2008 minutes. Shelly Lamb seconded, all in favor, motion carries to approve the October 2008 minutes.

3. Meet with SURPAC

- Patti Barrow provided an extensive update of the many successful activities and plans in the cultural arts community. The commission expressed a need for a future multi-purpose community space that would include a 250-300 seat theatre which would accommodate PCC, school, Let's Make Music, Sherwood Community Theatre, and other events. The group discussed the use of the URA owned "Old Machine Shop" as a potential space for this purpose. Mr. Nelson reported that Capstone Partners, LLC was currently developing a proposal for that property that may include space identified for Cultural Arts and a Community Center. Capstone has significant experience in developing this kind of space and in redeveloping old warehouse properties. He plans to connect with Patti Barrow and other interested parties when the proposal is received to discuss how the building might meet the needs expressed. Mr. Cottle also expressed, and received consensus among SURPAC members, that the \$1 million spent on the Machine Shop was not necessarily the same \$1million previously earmarked for Cultural Arts, but that a proportion of building purchase might be assigned in the future, relative to the space actually used for cultural arts activities.
- 4. Stella Olsen Park Stage Cover review with Parks Board—Kristen
 - The new conceptual design by OTAK was presented, which was very well received.
 Suggested that the current poles be removed, back slats be vertical, and the material used be low maintenance.
- 5. Holiday Art Walk update—Patti (exhibit A)
 - The Holiday Art Walk will be at the Morback House on December 6, 2008. The Tualatin Brass Band will be playing.
- 6. Comedy Sportz—Patti
 - Comedy Sportz will be either January 24 or January 31, 2009. The high school's availability will be confirmed. Tickets will be \$7.00.
- 7. Storage facility at old PW—Kristen/Robyn
 - The Cultural Arts Commission has things stored in the old public works building. The commission agreed to let the high school chose anything they may want first, before selling anything.
 - Patti Barrow motioned to sell whatever needs to be sold. Griff O'Brien seconded, all in favor, motion carried.

(Strengths, Weaknesses, Opportunities, Threats)

Strengths

- Reenergized and diverse board. Broad range of education and experiences.
- Public support and interest in longevity of existing events.
- Commitment to development of existing events.
- Partnerships and support that allow for keeping event costs to a minimum (movie equipment, sound equipment for movies in the park, waiving of rental fees at PAC).
- Relationships with old town merchants and arts based businesses.
- Branching off and forming 501C3—Sherwood Foundation for the Arts.
- Commitment to exploring, developing, and executing new traditions and activities.
- Enthusiasm in working with and promoting other organizations in Sherwood (Heritage Center, Robin Hood Festival, Voices for Performing Arts, etc.)

Weaknesses

- Limitation of manpower and ability for existing members to take on additional tasks.
- Lack of volunteer base.
- Lack of facility/home.
- Limited budget.
- Reliance on city for administrative support.
- Current website usability is difficult to navigate and lacks updated information on events.
- Only contact information listed on the website is <u>CulturalArtsCommission@ci.sherwood.or.us</u>

Opportunities

- Knowledge of grant opportunities.
- Sponsorship opportunities for financial support with events.
- Development of new programs and events with the goal to bring more art opportunities to the public.
- Development of new marketing materials to be used in gaining additional community involvement and support.
- Development of one time volunteer opportunities for yearly events.
- Opportunities for relationship development between various members of the arts community to work together in creating goals and avenues for accomplishment.
- Materials to be developed to market arts in Sherwood to the public and bring awareness to existing and new arts opportunities.
- Grant writing seminars.
- Collecting information of those in the community who would be willing to teach classes in different art formats.
- Odge Podge gallery allowing us to use garden space for events, gardening and art classes.

Threats

- Diminishing means of self-supporting/self-funding events.
- Need to develop unique fundraiser for continued/annual support.
- No clear plan of where/when a facility will be built. Limits future event planning.
- Large events limited to availability of High School PAC scheduling can be moved if school functions change, or building schedule changes.
