1. Call to Order/Roll Call (Pedersen)

2. Adjustments to Agenda (Pedersen)

3. Approval of October 2010 Minutes (Pedersen)

5. Cultural Arts Community Center Steering Committee Report (Pedersen)

- On Tuesday evening staff recommended the 80/20 Cultural Arts Community Center plan (formerly known as the 70/30 plan) during the URA work session. On November 16 the recommendation will be presented to the URA Board as well as a request for funds to support a business/operation plan. Staff is doing research to put out a RFP to do that work.
- Linda inquired about any remaining funds from the design process, and suggested to use any remaining funds for a business/operating plan which will be the next focus for the CACCSC.

Theater. At the last meeting, the group discussed looking at the last week of June, which

The group decided to schedule Missoula Children's Theater during the first two weeks in
August.

7. Council Update (Henderson)

- At the City Council work session on Tuesday, the new restrooms at Stella Olsen Memorial Park, the Skate Park, and the Community Center were discussed. Linda shared the background of the restroom project and the four phase build for the Skate Park.
- The commission discussed the restrooms and supports the higher end restroom for Stella Olsen since it is a high profile park.

8. Other

- The McCabe Real Estate Group has submitted payment to be the presenting sponsor for 2011 Movies in the Park.
- The Art Selection Committee members have been chosen. They will work on the process for selecting the plaza community art. Kristen would like to add one more local artist on the committee and asked the group if they had any suggestions.
