Hi Maggie,

My name is Danielle Davis and I am the Collections Registrar with the Regional Arts and Culture Council. Valerie Otani suggested I contact you regarding finding of a new home for one of our outdoor sculptures. It is called *Beside Ourselves* by Christine Bourdette and is currently located at the Juvenile Justice Center. There are 14 topiary cages intended to create a peaceful space that provides a counterpoint to the confined nature of the detention facility. It is supposed to incorporate plantings that we have never had success with given the water-laden soil at the site. Without the plantings, the context gives the impression of caged or shackled figures which is completely at odds with what Christine had wanted. Understandably the staff at the JJC have been dissatisfied with the sculpture for a long time now and have finally asked for its removal.

We have decided to deaccession the sculpture but so far have been unable to find someone willing to take it. Can you think of any sites that might work in your area? Christine does not want the pieces and I'm afraid that our only other option is to recycle them. We would like to avoid this if at all possible. I have attached a few photos and a fact sheet. If you would like any more information just let me know. Any help you can provide is greatly appreciated.
