

A SPECIAL MEETING OF THE SHERWOOD CITY COUNCIL WAS HELD AT THE CITY HALL IN SHERWOOD, OREGON, ON NOVEMBER 15, 1963.

The meeting was called to order by Mayor Ray Lien at 8 p. m.

The following named officials were present:-Mayor, Ray Lien, Councilmen:- Heater, Moore, Dahlke and Weston. City Attorney, Fred A. Anderson and Recorder, Albert.

It was announced by the Mayor that the Special meeting was called for the purpose of reviewing certain city ordinances which had been tabled at a previous meeting with Attorney David Saari, at whose direction the Sherwood City Ordinances are in the process of being codified. ~~xxxx~~ The council may also take up other urgent matters which may properly come before ~~the~~ it.

Under "Utilities Chapter", Ordinance No. 514 will be redrafted by Attorney Anderson to meet objections.

Under "Sanitation Chapter", a new, modern ordinance is to be presented by Attorney Anderson to replace No. 46, titled Garbage Regulations. The ordinances pertaining to Sewer Regulations and Sewer Charges shall be replaced to meet more adequately the current and anticipated future requirements as to connections, type and quality of sewage which the City will accept to be discharged into its sewer lines and its disposal facilities. Attorney Anderson will submit ordinances which will be designed to meet the approval of the council.

Under "Offense Chapter", Ordinances No. 1, 4, 8 and 12 to be consolidated and, preferably, modernized to meet present problems. Attorney Anderson is authorized and instructed to draft suitable ordinance. It was suggested that the ordinances under this chapter which had previously been marked for "Repeal", should be repealed and that The Yamhill Ordinance Under the Title of Nuisances be studied for ultimate consideration and adoption. That a copy of a suitable Curfew ordinance to conform with State laws be submitted to the Council by Attorney Anderson.

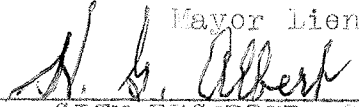
Under "Traffic Chapter", it was agreed that an ordinance be drafted to embrace a complete text of the State Law on Motor Vehicles and Traffic.

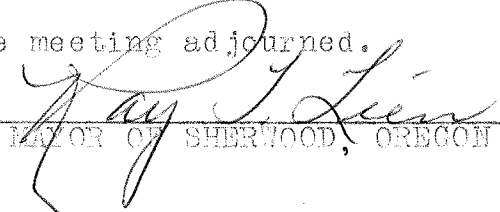
Under "Public Protection Chapter", it was agreed that The Board of Underwriters Code be adopted.

Under "Building Chapter", it was suggested that several minor changes be made in the Building Code to modernize it to meet present methods of construction, etc.

Attorney Anderson stated that he would submit to Attorney Saari copies of redrafted ordinances and some he had previously prepared for the City of Tigard. He would do so upon a proposed visit to Eugene, Oregon, on other business within the next week or two.
