KNOW ALL MEN BY THESE PRESENTS, That we, FERD LANGER and GERTRUDE LANGER, husband and wife, and CLARENCE LANGER and LILLIAN LANGER, husband and wife, Grantors, for and in consideration of the sum of One and No/100 (\$1.00) Dollars and the benefits accruing to Grantors herefrom, do hereby grant, bargain, sell and convey to the CITY OF SHERWOOD, Oregon, a municipal corporation duly organized and existing under the laws of the State of Oregon, Grantee, the following described interest in real property in the County of Washington and State of Oregon:

A perpetual right of way and easement for an underground 2" water pipeline upon, through, under and across the lands of the Grantors, including the right of ingress thereto and egress therefrom at all reasonable times by agents, contractors and employees of the Grantee, and the right to excavate for, construct, reconstruct and maintain within said right of way a water supply pipeline to be laid at a depth of approximately 24"; said right of way and easement to extend five (5) feet on each side of the center line described as follows:

In the Northwest Quarter of the Northwest Quarter of the Southwest Quarter of Section 29, Township 2 South of Range 1 West, Willamette Meridian, in Washington County, Oregon, beginning at a point approximately 30 feet East of the West line of the said Southwest quarter of said Section 29, and running thence Northeasterly 25 feet, more or less, to the South right of way line of the Six Corners-Cipole County Road.

The rights and privileges herein granted to the Grantee are subject to and conditioned that the Grantee, its agents, employees and contractors shall suffer or do no damage to said property unless the same is fully repaired, shall restore grounds as nearly as possible and reasonable to the pre-existing condition, shall install, maintain and operate said pipeline at Grantee's expense in such manner and to such extent as to not unduly interfere with the continued use and enjoyment of the property by the Grantors for purposes not incompatible with the rights herein granted, and shall save and hold harmless the Grantors from any liability or damages whatsoever arising in connection with the Grantee's activities on said property.

The Grantors hereby warrant that they are possessed of a fee simple title and estate in the above described lands and that they have a full legal right to grant unto the Grantee herein named the easement right and privileges hereinabove set forth.
