

KNOW ALL MEN BY THESE PRESENTS, That we, Elma E. Rehwalt, single, J. M. Burge and Ann C. Burge, husband and wife, Marion O. McCollum and Alice McCollum, husband and wife, and Earl A. Knight and Betty G. Knight, husband and wife,

hereinafter termed the Grantors, with respect to such of the herein-after described property standing of record in our respective names, for and in consideration of One and no/100 (\$1.00) and other valuable consideration, do hereby grant, bargain, sell and convey to the CITY OF SHERWOOD, Oregon, a corporate municipality existing under the laws of the State of Oregon in Washington County, Grantee, the following described lands for road and street purposes in the City of Sherwood, County of Washington and State of Oregon, to-wit:

A strip of land 16 1/2 feet on either side of the following described center line:

Beginning at a point North 89° 25' West 1318.6 feet from the center of Section 32, Township 2 South, Range 1 West, W.M., which point occurs in the approximate center of the Sherwood-Parrett Mountain public road; thence North 89° 25' West along the South lines of Parcel 1 and Parcel 2 to the Northeast corner of Parcel 3, as said Parcels 1, 2 and 3 are described in deed from Gustave Hanke to J. M. Burge dated March 5, 1945, and recorded in Book 240 at page 643, Deed Records of Washington County, Oregon;

It being the intent of this instrument to convey to the City of Sherwood for road and street purposes a strip of land 33 feet wide, of which 16 1/2 feet is being granted herein by each of the owners of lands abutting the said center line on the North and abutting said center line on the South.

TO HAVE AND TO HOLD the said lands to the CITY OF SHERWOOD, its successors and assigns forever.

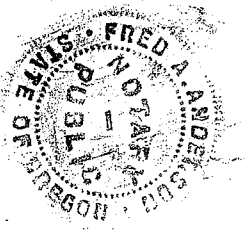
