## DEED OF DEDICATION

KNOW ALL MEN BY THESE PRESENTS, That SCHOOL DISTRICT #88J, hereinafter termed Grantor, for and in consideration of the sum of One Dollar and other valuable consideration and the benefits to be derived hereunder, does hereby give, grant and dedicate TO THE PUBLIC and TO THE CITY OF SHERWOOD, a municipality of the State of Oregon, for public road purposes the following described lands in the County of Washington, State of Oregon:

Beginning at the southwest corner of that tract of land in the southeast quarter of the northeast quarter of Section 31, T2S, RlW, W.M., Washington County, Oregon, conveyed to Union High School District No. 9 joint (Sherwood) as described in Book 563 at Page 618 of the Washington County records, said southwest corner also being the beginning point of the center line of that 20 foot roadway described in Book 115 at Pages 52 and 53 of the said records; thence from said described beginning point, N 89°08'E 898 feet, along said center line to the most southerly southeast corner of the said school tract; thence N0°29'W 30.00 feet, along an easterly line of the said school tract; thence S89°08'W 898 feet to the west line of the said school tract; thence S0°39'E 30.00 feet to the point of beginning.
