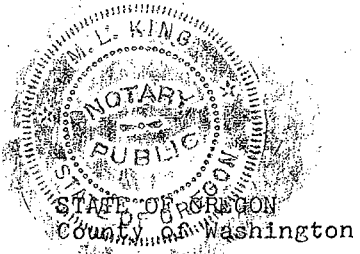

KNOW ALL MEN BY THESE PRESENTS, that DONALD E. POLLOCK and JULIA G. POLLOCK, husband and wife, hereinafter termed grantors, for and in consideration of the sum of One Dollar and other valuable consideration and the benefits to be derived hereunder, do hereby give, grant, and dedicate TO THE PUBLIC and TO THE CITY OF SHERWOOD, a municipality of the State of Oregon, for public road purposes the following described lands in the County of Washington, State of Oregon:

Beginning at the point of intersection of the northerly line of County Road No. 449 (a 40-foot wide road) with the westerly line of Section 32, T2S, R1W, W.M. Washington County, Oregon, thence S 81°59'06" East 130.98 feet along the northerly line of County Road No. 449, to angle point; thence N 75°13' E 375.91 feet, along the northerly line of said County Road No. 449, to the southeast corner of that tract of land described in Book 756 at page 733 of the Washington County Records; thence N 54°56' W 13.08 feet along the easterly line thereof; thence S 75°13' W 331.18 feet; thence on a 170.00 foot radius curve to the right 67.64 feet along the arc (long chord bears S 86°36'57" West 61.20 feet); thence N 81°59'06" West 96.23 feet to the westerly line of Section 32; thence S 0°46'42" East 10.12 feet to the point of beginning.

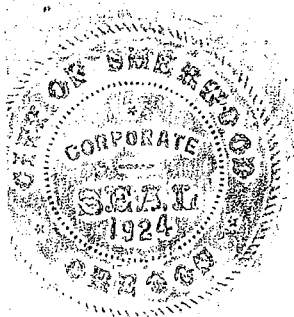
