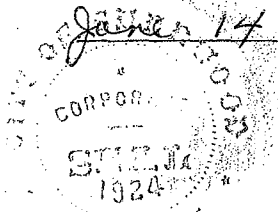
KNOW ALL MEN BY THESE PRESENTS, that the City of Sherwood,
