The south 20.00 feet of a parcel of land which parallels the northerly right-of-way line of NW Washington Street conveyed to the Sherwood Methodist Church, by instrument recorded in Book 703 at page 629 of Washington County Deed Records.

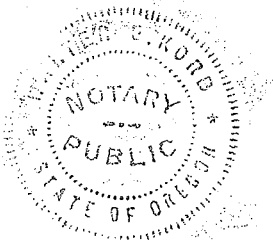
