WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That CLARENCE DEAN LANGER, also known as Clarence D. Langer, and LILLIAN LAVERNE LANGER, huband and wife; FERDINAND CANSED TRANSPORT AND CARSED OF SHERWOOD, a municipal corporation of the State of Oregon, Grantee, the following described property, to wit:

PARCEL 1

A parcel of land lying in the SW% of Section 29, Township 2 South, Range 1 West, W.M., Washington County, Oregon and being a portion of that property described in that deed to Lillian Laverne Langer, recorded in Book 378, Page 288 of Washington County Deed Records; the said parcel being that portion of said property included in a strip of land variable in width, lying on the Easterly and Southerly side of the center line of N. Sherwood Boulevard and S. W. Edy Road as said boulevard and road have been relocated, which center line is described as follows:

Beginning at Engineer's center line Station 30+74.42, said station being 821.67 feet North and 131.98 feet East of the Southwest corner of said Section 29; thence on a 477.47 foot radius curve right (the long chord of which bears North 22° 18' 18.5" West) 368.18 feet; thence North 0° 12' 52" West 1205.77 feet; thence on a 150 foot radius curve right (the long chord of which bears North 23° 21' 15.5" East) 123.41 feet; thence North 46° 55' 23" East 199.85 feet; thence on a 150 foot radius curve right (the long chord of which bears North 68° 24' 15.5" East) 112.48 feet; thence North 89° 53' 08" East 865.89 feet to Engineer's center line Station 59+50 at which station the Easterly line of said strip of land lies at right angles to said center line.

There also is hereby granted and conveyed to Grantee, its successors and assigns, a permanent easement to construct, operate and maintain a drainage facility over and across the following described property, to wit:

PARCEL 2

A parcel of land lying in the SW4 of Section 29, Township 2 South, Range 1 West, W.M., Washington County, Oregon; the said parcel being that portion of said SW4 lying between lines at right angles to the center line of relocated N.

Sherwood Boulevard at Engineer's Stations 32+92 and 33+07, and between lines parallel with and 30 feet Easterly and 40 feet Easterly of said center line, which center line is described in Parcel 1, containing 150 square feet, more or less.

This instrument does not grant or convey any right or title to the land described above as Parcel 2, except for the purpose of constructing, operating and maintaining a drainage facility thereon; it being further understood that nothing herein contained shall be construed to impose any duty, obligation or liability upon Grantee, by reason of the construction, operation or maintenance of said facility.

And Grantors do hereby covenant to and with Grantee, its successors and assigns, that they are the owners in fee simple of the said property which is free from all encumbrances and will warrant and defend the property herein conveyed and the easement rights herein granted from all lawful claims whatsoever.
