EASEMENT FOR SANITARY SEWERS

KNOW ALL MEN BY THESE PRESENTS that JAMES M. DAILEY and NANCY DAILEY, of the County of Washington, State of Oregon, in consideration of the sum of Four Thousand Seven Hundred Dollars (\$4,700.00) to them in hand paid, do hereby grant and convey unto the City of Sherwood, a municipal corporation organized and existing under the laws of the State of Oregon, permanent easement and temporary easement over across and under the property described on Exhibit A attached hereto. This permanent easement is granted for the purpose of maintaining sanitary sewers thereunder, and the easement herein granted shall include the right for the Grantee to go over and under said land for the purposes of maintaining and repairing said sanitary sewers.

Grantors reserve the unrestricted right to use of the easement area in any manner that does not interfere with or restrict, and is not incompatible with grantee's use of the easement for the purposes for which same is granted.

This right of way and easement is granted with the understanding that any work done by the City of Sherwood pursuant hereto will be done as to leave the premises herein described in a condition reasonably similar to the previous state thereof when any work is finished thereon, as is reasonable practicable and consistent with the purposes of the easement.

TO HAVE AND TO HOLD the herein described permanent easement unto the CITY OF SHERWOOD, its successors and assigns, forever. The temporary easement shall terminate upon acceptance by the City of Sherwood of the work performed by the contractor installing the sanitary sewer line.


