KNOW ALL MEN BY THESE PRESENTS That Ronald G. Harris

of the County of Washington, State of Oregon, in consideration of the sum of One and No/100 Dollars (\$1.00) to them in hand paid, do hereby grant and convey unto the City of Sherwood, a municipal corporation organized and existing under the laws of the State of Oregon, a right of way and easement over, across and under the following described real property situated in the County of Washington, State of Oregon, to-wit:

SEE EXHIBIT "A"

This permanent easement is granted for the purpose of maintaining roadway cut or fill slopes thereunder, and the easement herein granted shall include the right for the Grantee to go over and under said land for the purpose of maintaining and repairing said slopes.

Grantors covenant to and with Grantee that they will not in any manner interfere with or restrict, except as herein stated, Grantee's use of said easement.

This right of way and easement is granted with the understanding that any work done by the City of Sherwood, pursuant hereto will be done as to leave the premises herein described in a condition reasonably similar to the previous state thereof when any work is finished thereon.

TO HAVE AND TO HOLD THE Herein described right of way and easement unto the City of Sherwood, its successors and assigns, forever.

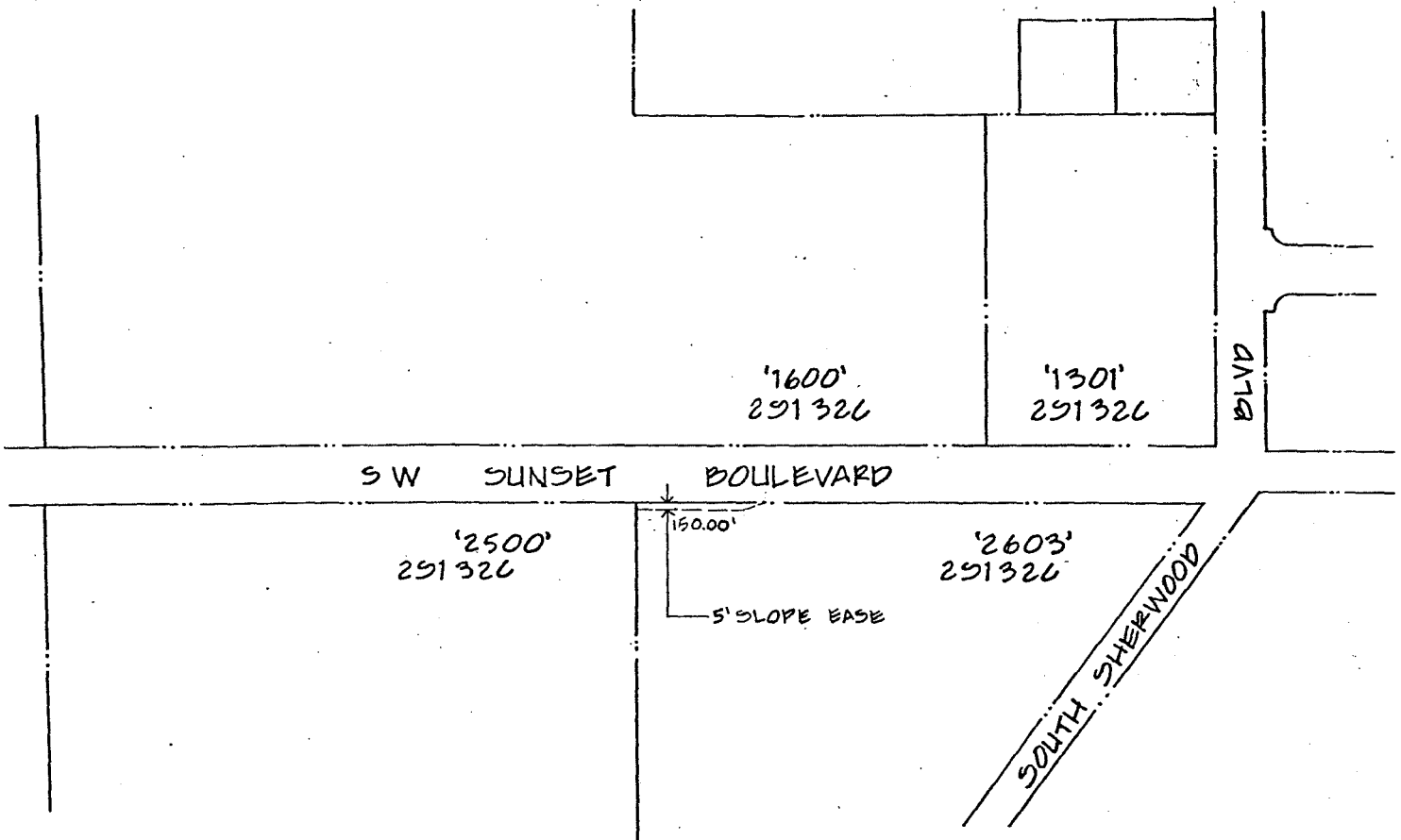

SLOPE EASEMENT

An easement for the purpose of constructing and maintaining a roadway cut or fill slope, across a tract of land situated in Section 32, T.2S., R.1W., W.M., Washington County, Oregon, more particularly described as follows:

Beginning at the intersection of the southerly right-of-way line of S.W. Sunset Boulevard and the westerly line of that tract of land described by Deed recorded as Fee No. 82018935; thence southerly, along the said westerly line 5.00 feet; thence easterly, parallel with and 5.00 feet southerly of the said southerly right-of-way line, 150.00 feet; thence north-easterly to a point on the said southerly right-of-way line, said point being 175.00 feet easterly of the point of beginning; thence westerly, along the said southerly right-of-way line, 175.00 feet to the point of beginning.

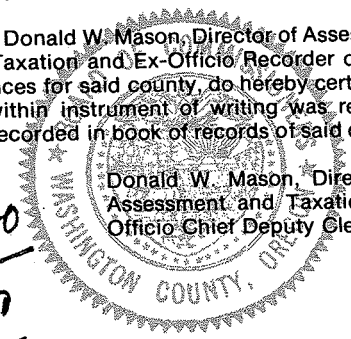
