

## DEDICATION WATER EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that DAVID E. CEREGHINO, JO ANN CEREGHINO, GERDA CEREGHINO, RUTH J. FISHER, FRED J. HOPP, JIM DOUGHERTY, as their separate interests may appear hereinafter termed "Grantor", in consideration of the benefits to accrue to grantor from grant herein set forth, does hereby give, grant, dedicate and convey to the CITY OF SHERWOOD and the public a perpetual right-of-way and easement for purposes of installation and maintenanceof a public water main under and within the following described parcel of real property situated in Washington County, Oregon:

Being a strip of land 15' in width extending 15' to the West of a center line, more particularly described as follows:

Situated in the Northwest quarter of Section 28, Township 2 South, Range 1 West, Willamette Meridian;

Beginning at a point which bears S.87°09'07"E., 376.69 feet from the west quarter corner of said Section 28; THENCE, along said centerline, N.5°19'19"W., 91.15 feet; THENCE, N.0°28'47"E., 497.73 feet; THENCE, N.1°59'38"E., 204.35 feet to the terminus of said centerline.

EXCEPTING THEREFROM any portion lying on or within the right-of-way of S.W. EDY ROAD.

Grantor covenants with grantee that it is the owner in fee simple of said property, which is free of all encumbrances, and will warrant and defend the easement rights herein granted from all lawful claims whatsoever.

No monetary consideration is being received by grantor for this easement from the City of Sherwood. Grantor is entitled to be reimbursed for a percentage of the main installation cost from the property owner(s) to the East when that property is developed and the grantee is prohibited from allowing any connections to this main until such cost is paid to the grantor.

TO HAVE AND TO HOLD the above described and granted easement unto the grantee and assigns forever.
