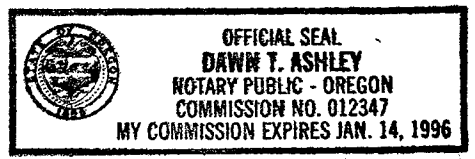

33' Road Dedication to the City of Sherwood described as follows:

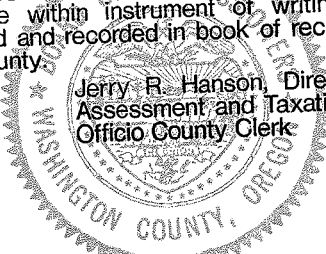
