LEGAL DESCRIPTION

N.W. SECOND ST. & N.E. ASH ST. CORNER CUT-OFF

That portion of Lot 1, Block 14, of the Smock Addition To Sherwood, (Plat Book 4, Page 25), Washington County Records, situated within the Northwest one-quarter of Section 32, Township 2 South and Range 1 West of the Willamette Meridian in the City of Sherwood, Washington County, State of Oregon, being more particularly described as follows:

Beginning at the northern most corner of said Lot 1; thence along the northwesterly line thereof, South 47° 41' 00" West 22.73 feet to a point of non-tangent curvature; thence along the arc of a 72.00 foot radius curve to the right, the radial center of which bears South 10° 13' 39" East, through a central angle of 25° 47' 50", an arc distance of 32.42 feet (the long chord of which bears South 87° 19' 44" East 32.15 feet) to a point of non-tangent curvature on the northeasterly line of said Lot 1; thence along said northeasterly line North 42° 20' 28" West 22.73 feet to the point of beginning.

Containing an area of 219 square feet, more or less.
