## QUITCLAIM DEED

THIS INDENTURE made this 20d day of October, 1990, by and between WASHINGTON COUNTY, a political subdivision of the State of Oregon, and City of Sherwood, a political subdivision of the State of Oregon, hereinafter called the Grantee:

### WITNESSETH:

WHEREAS, Washington County has acquired certain real property through the foreclosure of liens for delinquent taxes and described as 2S1 32 CA Tax Lot 2700 and more particularly described herein as beginning at a point on the Westerly line of said Andresen tract which bears South 00° 10' 30" West 309.00 feet from the Northwest corner of said Northeast Quarter of the Southwest Quarter, and running thence, south 89° 39' East 106.90 feet; thence, South 00°10' 30" West 50.00 feet to a point; thence North 89° 39' West 106.90 feet to a point on the Westerly line of said Andresen tract; thence, long said Westerly line, North 00° 10' 30" East 50.00 feet to the place of beginning, and

WHEREAS, ORS 271.330 authorizes the County to transfer property not needed by the County for public use to any governmental body and notice and public hearing were conducted pursuant to ORS 271.330; and
