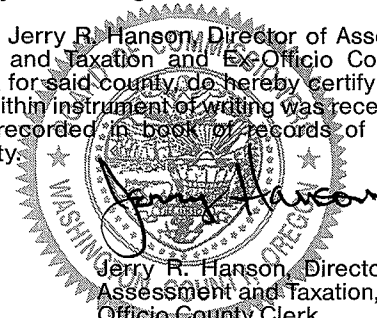

ORDINANCE NO. 95-1004

AN ORDINANCE CONCERNING THE VACATION OF A PORTION OF OLD HIGHWAY 99W (COUNTY ROAD NO. 1426), LOCATED NORTH OF SUNSET BOULEVARD, AND A PORTION OF SUNSET BOULEVARD (COUNTY ROAD NO. 441) LOCATED WEST OF THE NEW ALIGNMENT, IN THE CITY OF SHERWOOD, WASHINGTON COUNTY, OREGON, AND ESTABLISHING AN EFFECTIVE DATE.

WHEREAS, these portions of County Roads No. 1426 and 441 are dedicated public right-of-way giving the public rights over the land for street and utility improvements; and

WHEREAS, the purpose of this vacation is to vacate a portion of County Roads No. 1426 and 441 that are no longer needed for public use and because alternate access is being created; and

WHEREAS, 100 percent of the vestees of the adjacent land are not opposed to this vacation, and

WHEREAS, all affected service providers, including utility companies and emergency services, have reviewed this vacation proposal and either have no objections or have recommended specific conditions of approval which have been incorporated into this ordinance; and

WHEREAS, the Council having considered the request on November 14, 1995, finds that it is in the public interest to approve the request to vacate certain portions of public street right-of-way for County Roads No. 1426 and 441 because the public interest will not be prejudiced by this vacation as provided by ORS 271.120

NOW, THEREFORE, THE CITY ORDAINS AS FOLLOWS:


Section 1. Road Vacation. The Sherwood City Council hereby orders the vacation of certain portions of public street right-of-way, as described on the attached Exhibit A (map and legal description of areas to be vacated) and by this reference made part hereof.

Section 2. Effective Date. This ordinance shall become effective thirty (30) days after passage and approval.

Duly passed by the City Council this 14th day of November, 1995.


