## **Sanitary Sewer Easement**

The City of Sherwood A 15.00 foot wide Sanitary Sewer easement for the benefit of Edward Water Services, over those lands described and recorded in Document No. 98-144431, Washington County Deed Records, said easement being located in the Southeast one-quarter of Section 19, Township 2 South, Range 1 West, Willamette Meridian, City of Sherwood, Washington County, Oregon, as shown on attached Exhibit "A" and being more particularly described as follows:

Beginning at the one-quarter section corner common to Section 19 and Section 30, Township 2 South, Range 1 West, Willamette Meridian; thence along the common line of said sections North 89°24'51" East a distance of 425.49 feet to the **Point of Beginning**, said point also being on the southerly line of those lands described and recorded in Document No. 98-144431, and the northerly line of those lands described and recorded in Document No. 96-112595, Washington County Deed Records; thence leaving said line North 22°36'22" West a distance of 34.46 feet; thence North 67°23'38" East a distance of 15.00 feet; thence South 22°36'22" East a distance of 40.52 feet to a point on said common line; thence continuing along said common line South 89°24'51" West a distance of 16.18 feet to the **Point of Beginning**.


